1.As used in this contract "ticket" means this passenger ticket and baggage check, or this itinerary/receipt if applicable, in the case of an electronic ticket, of which thes e conditions and the notices form part, "carriage" is equivalent to "transportation", "c arrier" means all air carriers that carry or undertake to carry the passenger or his ba ggage hereunder or perform any other service incidental to such air carriage, "electr onic ticket" means the itinerary/receipt issued by or on behalf of Carrier, the Electro nic Coupons and, if applicable, a boarding document. "Warsaw Convention" means the Convention for the Unification of Certain Rules Relating to International Carriag e by Air signed at Warsaw, 12th October 1929 or that Convention as amended at T he Hague, 28th September 1955, whichever may be applicable. "Montreal Conventi on" means the Convention for the Unification of Certain Rules for International Carria ge by Air signed at Montreal, 28 May 1999.

2. Carriage hereunder is subject to the rules and limitations relating to liability establ ished by the Warsaw Convention or the Montreal Convention unless such carriage i s not "International carriage" as defined by that Convention.

3. - ADVICE TO INTERNATIONAL PASSENGERS ON LIMITATION OF LIABILITY
