# **Ticket Validity**

### Confirm separately

## **Itinerary Change**

- Changing Departure Date/Flight: Confirm separately (with reissue charge)
- Additional fare difference, tax, and surcharges may be imposed upon recalculating on the date of change
- Changing Arrival Date/Flight: Confirm separately
- Reissue charge or fare difference will be imposed if the fare condition changes

## **Route Change**

- ▶ Outbound Flight Route Change : Confirm separately
- Additional fare difference, tax, surcharges and reissue charge may be imposed upon recalculating on the date of change
- ▶ Inbound Flight Route Change : Confirm separately
  - Additional fare difference, tax, surcharges and reissue charge may be imposed upon recalculating on the date of change

#### Reissuance

- ▶ Available (Reissue charge Confirm separately)
  - Additional fare difference, tax, surcharges and reissue charge may be imposed upon recalculating on the date of change
- For tickets with combined booking classes, different reissue charge may be imposed based on the applicable fare and route.

- Refund must be requested within 30 days prior to the expiration date of the ticket.
- In case of discounted fare for infant/child, the same discount rate will be applied to the refund fee.

# **No-Show Penalty**

No-show penalty will be imposed if the passenger does not cancel the flight before the departure time or not board the sched uled flight after check-in.

(KRW 120,000 will be charged if the passenger does not cancel the flight before the departure time / KRW 300,000 will be charged if the passenger does not board the scheduled flight after check-in)

Reissue or refund fee is applied based on separate rules.

### - CONDITIONS OF CONTRACT

- 1.As used in this contract "ticket" means this passenger ticket and baggage check, or this itinerary/receipt if applicable, in the case of an electronic ticket, of which thes e conditions and the notices form part, "carriage" is equivalent to "transportation", "carrier" means all air carriers that carry or undertake to carry the passenger or his baggage hereunder or perform any other service incidental to such air carriage, "el ectronic ticket" means the itinerary/receipt issued by or on behalf of Carrier, the Electronic Coupons and, if applicable, a boarding document. "Warsaw Convention" means the Convention for the Unification of Certain Rules Relating to International Carriage by Air signed at Warsaw, 12th October 1929 or that Convention as amended at The Hague, 28th September 1955, whichever may be applicable. "Montreal Convention" means the Convention for the Unification of Certain Rules for International Carriage by Air signed at Montreal, 28 May 1999.
- 2. Carriage hereunder is subject to the rules and limitations relating to liability estab lished by the Warsaw Convention or the Montreal Convention unless such carriage is not "International carriage" as defined by that Convention.
- 3. To the extent not in conflict with the foregoing carriage and other services performed by each carrier are subject to: (1) provisions contained in the ticket; (2) applica ble tariffs; (3) carrier's conditions of carriage and related regulations which are mad e part hereof (and are available on application at the offices of carrier), except in transportation between a place in the United States or Canada and any place outside thereof to which tariffs in force in those countries apply.
- 4. Carrier's name may be abbreviated in the ticket, the full name and its abbreviation being set forth in carrier's applicable tariffs; carrier's address shall be the airport of departure shown opposite the first abbreviation of carrier's name in the ticket; the agreed stopping places are those places set forth in this ticket or as shown in carrier's timetables as scheduled stopping places on the passenger's route; carriage to be performed hereunder by several successive carrier is regarded as a single operation.
- 5. An air carrier issuing a ticket for carriage over the lines of another air carrier does so only as its agent.
- 6. Any exclusion or limitation of liability of carrier shall apply to and be for the benefit of agents, servants and representatives of carrier and any person whose aircraft is used by carrier for carriage and its agents, servants and representatives.
- 7. Checked baggage will be delivered to bearer of the baggage tag. In the case of d amage to baggage moving in international transportation complaint must be made i writing or by electronic document to carrier forthwith after the discovery of the da mage and, at the latest, within seven days from the date of receipt; in the case of d elay or loss, complaint must be made within twenty-one days from the date on which the baggage has been placed at his/her disposal (in the case of delay) or should have been placed at his/her disposal (in the case of loss.) See tariffs or conditions of carriage regarding non-international transportation.
- 8. This ticket is good for carriage for one year from date of issue, except as otherwise provided in this ticket, in carrier's tariffs, conditions of carriage, or related regulations. The fare for carriage hereunder is subject to change prior to commencement of carriage. Carrier may refuse transportation if the applicable fare has not been paid
- 9. Times shown in timetables or elsewhere are not guaranteed and form no part of t his contract. Carrier may without notice substitute alternate carriers or aircraft, and may alter or omit stopping places shown on the ticket in case of necessity. Schedul es are subject to change without notice. Carrier assumes no responsibility for making connections.
- 10. Passenger shall comply with Government travel requirements, present exit, entry and other required documents and arrive at airport by time fixed by carrier or, if no time is fixed, early enough to complete departure procedures.
- 11. No agent, servant or representative of carrier has authority to alter, modify or wa ive any provision of this contract.

## - ADVICE TO INTERNATIONAL PASSENGERS ON LIMITATION OF LIABILITY

Passengers on a journey involving an ultimate destination or a stop in a country oth er than the country of departure are advised that international treaties known as the Montreal Convention, or its predecessor, the Warsaw Convention, including its ame ndments (The Warsaw Convention system), may apply to the entire journey, including any portion thereof within a country. For such passengers, the applicable treaty, including special contracts of carriage embodied in any applicable tariffs, governs and may limit the liability of the carrier.

## - NOTICE OF BAGGAGE LIABILITY LIMITATIONS

Liability for loss, delay, or damage to baggage is limited unless a higher value is de clared in advance and additional charges are paid. For international travel (includin g domestic portions of international journeys) the liability limit is approximately US \$20.00 per kilogram for checked baggage and US\$400.00 per passenger for unche cked baggage or other property. The liability of AAR is limited to 1,288 SDRs for checked and unchecked baggage where the Montreal Convention applies to your jour ney. For travel wholly between U.S. points, the airline's liability for loss, delay, or damage to baggage is limited to a maximum of US\$3,400 per ticketed passenger. Excess valuation may be declared on certain types of articles. Carriers' liability for fragil e, perishable or valuable articles is governed by the Montreal Convention or the General Conditions of Carriage. Further information may be obtained from the carrier.

## - SPECIAL NOTICE ON LIMIT OF LIABILITY

As to any claim arising out of death of or, wounding or other bodily injury to, a passe nger within the meaning of the Convention, AAR shall not avail itself of any defense under Article 20 of the Warsaw Convention, nor invoke the limitation of liability in Art to let 22 (1) of the Warsaw Convention as amended at the Hague, 1955 with respect to that portion of such claim which does not exceed 100,000 SDRs. In the case of carriage subject to the Montreal Convention, as to any claim arising under Article 17 of the Convention which does not exceed 128,821 SDRs, the carrier shall not be able to exclude or limit its liability. Above the 128,821 SDRs, the carrier shall not be liable if the carrier proves (1) it was not due to the negligence or other wrongful act or omission of the carrier, or (2) it was solely due to the negligence or other wrongful act or omission of a third party.

### - DENIDED BOARDING, CANCELLATION AND DELAY IN EU

In case of a denied boarding, flight cancellation or flight delay departing from EU m ember state, we offer assistance and compensation to the concerned passengers a ccording to the Regulation EC 261/2004.

### - DENIED BOARDING BY OVERBOOKING

In order to minimize the effect of "no shows" and to permit seats to be used by pass engers who otherwise would not be able to travel on a chosen flight, carriers may o verbook flights. Whilst carriers make every effort to provide seats for which confirme d reservations exist, seat availability is not absolutely guaranteed. In those countries where Denied Boarding Compensation regulations are in force, carriers operate c ompensation plans for passengers who are denied boarding because of non-availa bility of seats caused by overbooking. The ticket sold in the United States for transp ortation originating in the United States, we offer assistance and compensation to the concerned passengers according to the U.S.Federal Regulation. Details of these plans are available at the airlines' offices.

## - NOTICE OF GOVERNMENT IMPOSED TAXES, FEES AND CHARGES

The price of this ticket may include taxes, fees and charges which are imposed on a ir transportation by government authorities. These taxes, fees and charges, which may represent a significant portion of the cost of air travel, are either included in the fare, or shown separately in the "TAX/FEE/CHARGE" box(es) of this ticket. # - BOOKING CLASS
