Above the 128,821 SDRs, the carrier shall not be liable if the carrier proves (1) it was not due to the negligence or other wrongful act or omission of the carrier, or (2) it was solely due to the negligence or other wrongful at the result of the date.

- DENIDED BOARDING, CANCELLATION AND DELAY IN EU
