"Warsaw Convention" me ans the Convention for the Unification of Certain Rules Relating to International Carriage by Air signed at Warsaw, 12th October 1929 or that Convention as amended at The Hague, 28th September 1955, whichever may be applicable. "Montreal Con vention" means the Convention for the Unification of Certain Rules for International Carriage by Air signed at Montreal, 28 May 1999.

Passengers on a journey involving an ultimate destination or a stop in a country oth er than the country of departure are advised that international treaties known as the Montreal Convention, or its predecessor, the Warsaw Convention, including its ame ndments (The Warsaw Convention system), may apply to the entire journey, includi ng any portion thereof within a country. - NOTICE OF BAGGAGE LIABILITY LIMITATIONS

Liability for loss, delay, or damage to baggage is limited unless a higher value is de clared in advance and additional charges are paid. Above the 128,821 SDRs, the carrier shall not be liable if the carrier proves (1) it was not due to the negligence or other wrongful act or omission of the carrier, or (2) it was solely due to the negligence or other wrongful at the result of the dates.

- DENIDED BOARDING, CANCELLATION AND DELAY IN EU

In case of a denied boarding, flight cancellation or flight delay departing from EU m ember state, we offer assistance and compensation to the concerned passengers a coording to the Regulation EC 261/2004.

DENIED BOARDING BY OVERBOOKING

In order to minimize the effect of "no shows" and to permit seats to be used by pass engers who otherwise would not be able to travel on a chosen flight, carriers may o verbook flights.
