"Warsaw Convention" me ans the Convention for the Unification of Certain Rules Relating to International Carriage by Air signed at Warsaw, 12th October 1929 or that Convention as amended at The Hague, 28th September 1955, whichever may be applicable. "Montreal Con vention" means the Convention for the Unification of Certain Rules for International Carriage by Air signed at Montreal, 28 May 1999.

Carriage hereunder is subject to the rules and limitations relating to liability estab lished by the Warsaw Convention or the Montreal Convention unless such carriage is not "International carriage" as defined by that Convention.

3. 8. This ticket is good for carriage for one year from date of issue, except as otherwi se provided in this ticket, in carrier's tariffs, conditions of carriage, or related regulati ons. 11. No agent, servant or representative of carrier has authority to alter, modify or wa ive any provision of this contract.

#### - ADVICE TO INTERNATIONAL PASSENGERS ON LIMITATION OF LIABILITY

Above the 128,821 SDRs, the carrier shall not be lia ble if the carrier proves (1) it was not due to the negligence or other wrongful act or omission of the carrier, or (2) it was solely due to the negligence or other wrongful at the result of the darty.

#### - DENIDED BOARDING, CANCELLATION AND DELAY IN EU

In case of a denied boarding, flight cancellation or flight delay departing from EU m ember state, we offer assistance and compensation to the concerned passengers a coording to the Regulation EC 261/2004.

#### DENIED BOARDING BY OVERBOOKING

In order to minimize the effect of "no shows" and to permit seats to be used by pass engers who otherwise would not be able to travel on a chosen flight, carriers may o verbook flights.
