"Warsaw Convention" me ans the Convention for the Unification of Certain Rules Relating to International Carriage by Air signed at Warsaw, 12th October 1929 or that Convention as amended at The Hague, 28th September 1955, whichever may be applicable. - DENIDED BOARDING, CANCELLATION AND DELAY IN EU
