"Warsaw Convention" means the Convention for the Unification of Certain Rules Relating to International Carriag e by Air signed at Warsaw, 12th October 1929 or that Convention as amended at T he Hague, 28th September 1955, whichever may be applicable. "Montreal Conventi on" means the Convention for the Unification of Certain Rules for International Carri age by Air signed at Montreal, 28 May 1999.

ADVICE TO INTERNATIONAL PASSENGERS ON LIMITATION OF LIABILITY

Passengers on a journey involving an ultimate destination or a stop in a country oth er than the country of departure are advised that international treaties known as the Montreal Convention, or its predecessor, the Warsaw Convention, including its ame ndments (The Warsaw Convention system), may apply to the entire journey, includi ing any portion thereof within a country. - NOTICE OF BAGGAGE LIABILITY LIMITATIONS

Liability for loss, delay, or damage to baggage is limited unless a higher value is de clared in advance and additional charges are paid. - DENIDED BOARDING, CANCELLATION AND DELAY IN EU

DENIED BOARDING BY OVERBOOKING

In order to minimize the effect of "no shows" and to permit seats to be used by pass engers who otherwise would not be able to travel on a chosen flight, carriers may o verbook flights.
