"Warsaw Convention" means the Convention for the Unification of Certain Rules Relating to International Carriag e by Air signed at Warsaw, 12th October 1929 or that Convention as amended at T he Hague, 28th September 1955, whichever may be applicable. In the case of d amage to baggage moving in international transportation complaint must be made i n writing or by electronic document to carrier forthwith after the discovery of the da mage and, at the latest, within seven days from the date of receipt; in the case of d elay or loss, complaint must be made within twenty-one days from the date on which the baggage has been placed at his/her disposal (in the case of delay) or should have been placed at his/her disposal (in the case of loss.) 11. No agent, servant or representative of carrier has authority to alter, modify or wa ive any provision of this contract.

- ADVICE TO INTERNATIONAL PASSENGERS ON LIMITATION OF LIABILITY

Passengers on a journey involving an ultimate destination or a stop in a country oth er than the country of departure are advised that international treaties known as the Montreal Convention, or its predecessor, the Warsaw Convention, including its ame ndments (The Warsaw Convention system), may apply to the entire journey, includi ng any portion thereof within a country. - NOTICE OF BAGGAGE LIABILITY LIMITATIONS

Above the 128,821 SDRs, the carrier shall not be liable if the carrier proves (1) it was not due to the negligence or other wrongful act or omission of a third party.

- DENIDED BOARDING, CANCELLATION AND DELAY IN EU

DENIED BOARDING BY OVERBOOKING

In order to minimize the effect of "no shows" and to permit seats to be used by pass engers who otherwise would not be able to travel on a chosen flight, carriers may o verbook flights.
