1.As used in this contract "ticket" means this passenger ticket and baggage check, or this itinerary/receipt if applicable, in the case of an electronic ticket, of which thes e conditions and the notices form part, "carriage" is equivalent to "transportation", "c arrier" means all air carriers that carry or undertake to carry the passenger or his ba ggage hereunder or perform any other service incidental to such air carriage, "electr onic ticket" means the itinerary/receipt issued by or on behalf of Carrier, the Electro nic Coupons and, if applicable, a boarding document. "Warsaw Convention" means the Convention for the Unification of Certain Rules Relating to International Carriag e by Air signed at Warsaw, 12th October 1929 or that Convention as amended at T he Hague, 28th September 1955, whichever may be applicable. "Montreal Conventi on" means the Convention for the Unification of Certain Rules for International Carri age by Air signed at Montreal, 28 May 1999.

2. Carriage hereunder is subject to the rules and limitations relating to liability establ ished by the Warsaw Convention or the Montreal Convention unless such carriage i s not "International carriage" as defined by that Convention.

3. To the extent not in conflict with the foregoing carriage and other services perfor med by each carrier are subject to: (1) provisions contained in the ticket; (2) applica ble tariffs; (3) carrier's conditions of carriage and related regulations which are mad e part hereof (and are available on application at the offices of carrier), except in tra nsportation between a place in the United States or Canada and any place outside t hereof to which tariffs in force in those countries apply.

6. Any exclusion or limitation of liability of carrier shall apply to and be for the benefit to f agents, servants and representatives of carrier and any person whose aircraft is used by carrier for carriage and its agents, servants and representatives.

7. Checked baggage will be delivered to bearer of the baggage tag. In the case of d amage to baggage moving in international transportation complaint must be made i n writing or by electronic document to carrier forthwith after the discovery of the da mage and, at the latest, within seven days from the date of receipt; in the case of d elay or loss, complaint must be made within twenty-one days from the date on which he baggage has been placed at his/her disposal (in the case of delay) or should have been placed at his/her disposal (in the case of loss.) See tariffs or conditions o f carriage regarding non-international transportation.

8. This ticket is good for carriage for one year from date of issue, except as otherwi se provided in this ticket, in carrier's tariffs, conditions of carriage, or related regulati ons. The fare for carriage hereunder is subject to change prior to commencement o f carriage. Carrier may refuse transportation if the applicable fare has not been pai d.

9. Times shown in timetables or elsewhere are not guaranteed and form no part of t his contract. Carrier may without notice substitute alternate carriers or aircraft, and may alter or omit stopping places shown on the ticket in case of necessity. Schedul es are subject to change without notice. Carrier assumes no responsibility for makin g connections.

10. Passenger shall comply with Government travel requirements, present exit, entry and other required documents and arrive at airport by time fixed by carrier or, if no time is fixed, early enough to complete departure procedures.

11. No agent, servant or representative of carrier has authority to alter, modify or wa ive any provision of this contract.

- ADVICE TO INTERNATIONAL PASSENGERS ON LIMITATION OF LIABILITY

Passengers on a journey involving an ultimate destination or a stop in a country oth er than the country of departure are advised that international treaties known as the Montreal Convention, or its predecessor, the Warsaw Convention, including its ame ndments (The Warsaw Convention system), may apply to the entire journey, includi ng any portion thereof within a country. For such passengers, the applicable treaty, i ncluding special contracts of carriage embodied in any applicable tariffs, governs a nd may limit the liability of the carrier.

- NOTICE OF BAGGAGE LIABILITY LIMITATIONS

Liability for loss, delay, or damage to baggage is limited unless a higher value is de clared in advance and additional charges are paid. For international travel (includin g domestic portions of international journeys) the liability limit is approximately US \$20.00 per kilogram for checked baggage and US\$400.00 per passenger for unche cked baggage or other property. The liability of AAR is limited to 1,288 SDRs for ch ecked and unchecked baggage where the Montreal Convention applies to your jour ney. For travel wholly between U.S. points, the airline's liability for loss, delay, or da mage to baggage is limited to a maximum of US\$3,400 per ticketed passenger. Exc ess valuation may be declared on certain types of articles. - SPECIAL NOTICE ON LIMIT OF LIABILITY

In the case o f carriage subject to the Montreal Convention, as to any claim arising under Article 1 7 of the Convention which does not exceed 128,821 SDRs, the carrier shall not be able to exclude or limit its liability. Above the 128,821 SDRs, the carrier shall not be liable if the carrier proves (1) it was not due to the negligence or other wrongful act or omission of the carrier, or (2) it was solely due to the negligence or other wrongful lact or omission of a third party.

- DENIDED BOARDING, CANCELLATION AND DELAY IN EU

In case of a denied boarding, flight cancellation or flight delay departing from EU m ember state, we offer assistance and compensation to the concerned passengers a coording to the Regulation EC 261/2004.

- DENIED BOARDING BY OVERBOOKING

In order to minimize the effect of "no shows" and to permit seats to be used by pass engers who otherwise would not be able to travel on a chosen flight, carriers may o verbook flights. Whilst carriers make every effort to provide seats for which confirme d reservations exist, seat availability is not absolutely guaranteed. In those countrie s where Denied Boarding Compensation regulations are in force, carriers operate c ompensation plans for passengers who are denied boarding because of non-availa bility of seats caused by overbooking.
