- 1.As used in this contract "ticket" means this passenger ticket and baggage che ck, or this itinerary/receipt if applicable, in the case of an electronic ticket, of w hich these conditions and the notices form part, "carriage" is equivalent to "tra nsportation", "carrier" means all air carriers that carry or undertake to carry the p assenger or his baggage hereunder or perform any other service incidental to s uch air carriage, "electronic ticket" means the itinerary/receipt issued by or on b ehalf of Carrier, the Electronic Coupons and, if applicable, a boarding docume nt. "Warsaw Convention" means the Convention for the Unification of Certain R ules Relating to International Carriage by Air signed at Warsaw, 12th October 1 929 or that Convention as amended at The Hague, 28th September 1955, whi chever may be applicable. "Montreal Convention" means the Convention for the Unification of Certain Rules for International Carriage by Air signed at Montreal, 28 May 1999.
- 2. Carriage hereunder is subject to the rules and limitations relating to liability established by the Warsaw Convention or the Montreal Convention unless such carriage is not "International carriage" as defined by that Convention.
- 3. To the extent not in conflict with the foregoing carriage and other services p erformed by each carrier are subject to: (1) provisions contained in the ticket; (2) applicable tariffs; (3) carrier's conditions of carriage and related regulations which are made part hereof (and are available on application at the offices of carrier), except in transportation between a place in the United States or Cana da and any place outside thereof to which tariffs in force in those countries app ly.
- 4. Carrier's name may be abbreviated in the ticket, the full name and its abbre viation being set forth in carrier's applicable tariffs; carrier's address shall be the airport of departure shown opposite the first abbreviation of carrier's name in the ticket; the agreed stopping places are those places set forth in this ticket or as shown in carrier's timetables as scheduled stopping places on the passenger's route; carriage to be performed hereunder by several successive carrier is regard ed as a single operation.
- 5. An air camer issuing a ticket for camage over the lines of another air camer does so only as its agent.
- 6. Any exclusion or limitation of liability of carrier shall apply to and be for the benefit of agents, servants and representatives of carrier and any person whose aircraft is used by carrier for carriage and its agents, servants and representative s.
- 7. Checked baggage will be delivered to bearer of the baggage tag. In the case of damage to baggage moving in international transportation complaint must be made in writing or by electronic document to carrier forthwith after the disc overy of the damage and, at the latest, within seven days from the date of receipt; in the case of delay or loss, complaint must be made within twenty-one days from the date on which the baggage has been placed at his/her disposal (in the case of loss.) See tariffs or conditions of carriage regarding non-international transportation.
- 8. This ticket is good for carriage for one year from date of issue, except as oth erwise provided in this ticket, in carrier's tariffs, conditions of carriage, or related regulations. The fare for carriage hereunder is subject to change prior to comm encement of carriage. Carrier may refuse transportation if the applicable fare h as not been paid.
- 9. Times shown in timetables or elsewhere are not guaranteed and form no par t of this contract. Carrier may without notice substitute alternate carriers or aircr aft, and may alter or omit stopping places shown on the ticket in case of necess ity. Schedules are subject to change without notice. Carrier assumes no respons ibility for making connections.
- 10. Passenger shall comply with Government travel requirements, present exit, entry and other required documents and arrive at airport by time fixed by came r or, if no time is fixed, early enough to complete departure procedures.
- 11. No agent, servant or representative of carrier has authority to alter, modify o r waive any provision of this contract.

- ADVICE TO INTERNATIONAL PASSENGERS ON LIMITATION OF LIABILITY

Passengers on a journey involving an ultimate destination or a stop in a country other than the country of departure are advised that international treaties known as the Montreal Convention, or its predecessor, the Warsaw Convention, including its amendments (The Warsaw Convention system), may apply to the entire journey, including any portion thereof within a country. For such passengers, the applicable treaty, including special contracts of carriage embodied in any applicable tariffs, governs and may limit the liability of the carrier.

- NOTICE OF BAGGAGE LIABILITY LIMITATIONS

Liability for loss, delay, or damage to baggage is limited unless a higher value is declared in advance and additional charges are paid. For international trave I (including domestic portions of international journeys) the liability limit is approximately U\$\$20.00 per kilogram for checked baggage and U\$\$400.00 per p assenger for unchecked baggage or other property. The liability of AAR is limit ed to 1,288 SDRs for checked and unchecked baggage where the Montreal Convention applies to your journey. For travel wholly between U.S. points, the air ine's liability for loss, delay, or damage to baggage is limited to a maximum of U\$\$3,400 per ticketed passenger. Excess valuation may be declared on certain types of articles. Carriers' liability for fragile, perishable or valuable articles is governed by the Montreal Convention or the General Conditions of Carriage. Further information may be obtained from the carrier.

- SPECIAL NOTICE ON LIMIT OF LIABILITY

As to any claim arising out of death of or, wounding or other bodily injury to, a passenger within the meaning of the Convention, AAR shall not avail itself of a ny defense under Article 20 of the Warsaw Convention, nor invoke the limitatio n of liability in Article 22 (1) of the Warsaw Convention as amended at the Hag ue, 1955 with respect to that portion of such claim which does not exceed 100, 000 SDRs. In the case of carriage subject to the Montreal Convention, as to an y claim arising under Article 17 of the Convention which does not exceed 128, 821 SDRs, the carrier shall not be able to exclude or limit its liability. Above th e 128,821 SDRs, the carrier shall not be liable if the carrier proves (1) it was no t due to the negligence or other wrongful act or omission of the carrier, or (2) it was solely due to the negligence or other wrongful act or omission of a third party.

- DENIDED BOARDING, CANCELLATION AND DELAY IN EU

In case of a denied boarding, flight cancellation or flight delay departing from EU member state, we offer assistance and compensation to the concerned pass engers according to the Regulation EC 261/2004.

- DENIED BOARDING BY OVERBOOKING

In order to minimize the effect of "no shows" and to permit seats to be used by passengers who otherwise would not be able to travel on a chosen flight, carrie rs may overbook flights. Whilst carriers make every effort to provide seats for whi ch confirmed reservations exist, seat availability is not absolutely guaranteed. In those countries where Denied Boarding Compensation regulations are in force, carriers operate compensation plans for passengers who are denied boarding because of non-availability of seats caused by overbooking. The ticket sold in the United States for transportation originating in the United States, we offer as sistance and compensation to the concerned passengers according to the U.S. Federal Regulation.
