Passengers on a journey involving an ultimate destination or a stop in a country of er than the country of departure are advised that international treaties known as the Montreal Convention, or its predecessor, the Warsaw Convention, including its ame often the Convention system), may apply to the entire journey, including any portion thereof within a country. For such passengers, the applicable treaty, i ncluding special contracts of carriage embodied in any applicable tariffs, governs a nd may limit the liability of the carrier.

- NOTICE OF BAGGAGE LIABILITY LIMITATIONS
Liability for loss, delay, or damage to baggage is limited unless a higher value is de clared in advance and additional charges are paid. For international travel (includin g domestic portions of international journeys) the liability limit is approximately US \$20.00 per kilogram for checked baggage and US\$400.00 per passenger for unche cked baggage or other property. In the case o ct of that point on such claim willor does not exceed 10,000 SDRs. In the case of carriage subject to the Montreal Convention, as to any claim arising under Article 1 7 of the Convention which does not exceed 128,821 SDRs, the carrier shall not be able to exclude or limit its liability. Above the 128,821 SDRs, the carrier shall not be liable if the carrier proves (1) it was not due to the negligence or other wrongful act or omission of the carrier, or (2) it was solely due to the negligence or other wrongful act or omission of a third party.

- DENIDED BOARDING, CANCELLATION AND DELAY IN EU

DENIED BOARDING BY OVERBOOKING

In order to minimize the effect of "no shows" and to permit seats to be used by pass engers who otherwise would not be able to travel on a chosen flight, carriers may o engers who otherwise would not be able to travel of a closer hight; carriers may be verbook flights. Whilst carriers make every effort to provide seats for which confirme d reservations exist, seat availability is not absolutely guaranteed. In those countrie s where Denied Boarding Compensation regulations are in force, carriers operate c ompensation plans for passengers who are denied boarding because of non-availability of seats caused by overbooking.
