- ADVICE TO INTERNATIONAL PASSENGERS ON LIMITATION OF LIABILITY

- NOTICE OF BAGGAGE LIABILITY LIMITATIONS

Above the 128,821 SDRs, the carrier shall not be liable if the carrier proves (1) it was not due to the negligence or other wrongful act or omission of the carrier, or (2) it was solely due to the negligence or other wrongfu act or omission of a third party.

- DENIDED BOARDING, CANCELLATION AND DELAY IN EU

DENIED BOARDING BY OVERBOOKING

In order to minimize the effect of "no shows" and to permit seats to be used by pass engers who otherwise would not be able to travel on a chosen flight, carriers may o verbook flights.
